



# ACCESSORIAL PRICING SCHEDULE

ACCESSORIAL	APPLICABLE CHARGES
<b>STOP OFF CHARGE:</b>	Single: \$65 for 1st or 2nd stop, \$105 for each additional stop thereafter. Team/Expedited: \$125 for 1st stop, \$175 for 2nd stop, \$225 for 3rd stop, \$150 for each additional stop thereafter.
<b>DRIVER ASSIST:</b>	\$.27 per hundred weight; Minimum Charge: \$150 Stopping in transit for partial loading/unloading: \$80 per stop.
<b>RECONSIGNMENT:</b>	\$110 per occurrence. Rates & miles are computed in the same manner as stop-off shipment.
<b>CARGO LIABILITY:</b>	\$100,000 release value; \$2 per \$1,000 of additional declared value.
<b>PALLET EXCHANGE:</b>	\$170 per trailer or \$7 per pallet whichever is less
<b>LAYOVER:</b>	\$300 per night for first 2 nights; \$400 per night thereafter
<b>REDELIVERY:</b>	Over-the-road: \$125 in addition to any layover fees Inter-Modal: \$200 in addition to any layover fees
<b>PROTECTIVE SERVICES (HEAT or COLD):</b>	Additional 20% added to line haul.
<b>DRIVER DETENTION:</b>	Over-the-road: 2 hours free, then \$15 per 15 minutes or fraction thereof. Inter-Modal: 2 hours free, then \$20 per 15 minutes or fraction thereof.
<b>FUEL SURCHARGE:</b>	Based on weekly DOE diesel fuel price.
<b>PAYMENT TERMS:</b>	Payments shall be made within 15 days of shipment delivery. If payment terms are exceeded, interest charges may apply.
<b>LOADS LESS THAN 200 MILES PREMIUM:</b>	Shipments less than 200 miles are subject to a minimum line haul charge of \$400 plus current fuel surcharge.
<b>TRUCK ORDER NOT USED:</b>	Over-the-road: \$250 ; Inter-Modal: \$350
<b>IN BOND:</b>	Moving freight under "in bond" conditions, \$50 per shipment.
<b>NEW YORK SERVICE:</b>	\$125 charge per vehicle for all shipments picking up or delivering to the following: Bronx, Brooklyn, Manhattan, Queens, Staten Island, Nassau & Suffolk counties, and any zip codes between 100-105 & 110-119
